ORBIT INTERNATIONAL CORP. POWER UNIT SEGMENT RECEIVES NEW ORDER TO SUPPORT ROYAL AUSTRALIAN AIR FORCE PROGRAM

Hauppauge, New York, April 24, 2002—Orbit International Corp.(NASDAQ:ORBT) today announced that its Power Unit Segment, Behlman Electronics, Inc., has received an order from BAE Systems for approximately \$340,000 for a display power supply to be used in the Royal Australian Air Force's Wedgetail Program, a 737-700 airborne early warning and control (AEW&C) system. The Wedgetail Program is the Royal Australian Air Force's new AEW&C system that has complete interoperability with the E-3 and 767 AWACS aircraft surveillance systems. The order calls for design and delivery of five (5) qualification units in September 2002 and production deliveries to commence in January 2003.

Mark Tublisky, President of Behlman Electronics Inc. commented, "We are pleased to have received this order from BAE Systems after having previously supplied power supplies to this customer on other programs. In addition to this order, Behlman is currently pursuing separate program requirements with BAE to design and build two power supply configurations for the Wedgetail system".

Dennis Sunshine, President and CEO of Orbit commented, "Behlman's Custom Power Division has seen enormous growth in bookings over the past 18 months for orders for its Commercial Off-The-Shelf (COTS) solutions for customer power requirements. In addition to this order from BAE, the Custom Power Division has recently booked significant orders from Raytheon and the U.S. Government that could include potential follow-on production requirements. Furthermore, Behlman is continuing to build upon its reputation as a leader in COTS solutions, which should lead to continued growth in our Custom Power Division".

Orbit International Corp., based in Hauppauge, New York, is involved in the manufacture of customized electronic components and subsystems for military and nonmilitary government applications. Its Behlman Electronics, Inc. subsidiary manufactures and sells high quality commercial power units and low noise uninterruptable power supplies (UPS). The Behlman custom division designs, manufactures and sells power units and electronic products for measurement and display.
